NOTICE-AND-ACCESS NOTIFICATION TO SHAREHOLDERS

You are receiving this notification as Natcore Technology Inc. (the “Company”) has decided to use the notice and access model for delivery of meeting materials for its 2019 Annual General Meeting (“Meeting”) to its shareholders. This Notice of Meeting is prepared under the notice-and-access rules that came into effect on February 11, 2013 under National Instrument 54-101 *Communication with Beneficial Owners of Securities of a Reporting Issuer*. Under notice and access, shareholders still receive a proxy or voting instruction form enabling them to vote at the Meeting. However, instead of a paper copy of the Information Circular, shareholders receive this notice with information on how they may access such materials electronically. The use of this alternative means of delivery is more environmentally responsible as it will help reduce paper use and also will reduce the cost of printing and mailing materials to shareholders. The Company will not use procedures known as ‘stratification’ in relation to the use of Notice-and-Access Provisions. Stratification occurs when a reporting issuer using the Notice-and-Access Provisions provides a paper copy of the information circular to some shareholders with this notice package. In relation to the Meeting, all shareholders will receive the required documentation under the Notice-and-Access Provisions, which will not include a paper copy of the Circular.

SHAREHOLDERS WILL BE ASKED TO CONSIDER AND VOTE ON THE FOLLOWING MATTERS:

1. To receive the audited financial statements of the Company for the fiscal year ended December 31, 2017 together with the auditors’ report thereon. See “*Particulars of Matters to be Acted Upon - Receipt of Financial Statements*” in the Circular (as defined below);
2. To fix the number of directors to be elected for the ensuing year at three. See “*Particulars of Matters to be Acted Upon Election of Directors*” in the Circular;
3. To elect directors of the Company for the ensuing year. See “*Particulars of Matters to be Acted Upon - Election of Directors*” in the Circular;
4. To appoint the auditors for the Company for the ensuing year and authorize the Directors to fix the auditors’ remuneration. See “*Particulars of Matters to be Acted Upon - Appointment of Auditor*” in the Circular; and

5. To transact such further or other business as may properly come before the Meeting or any adjournment or adjournments thereof.

Reference is made to the management information circular of the Company dated December ----, 2018 (the "Circular") which contains additional details concerning the matters outlined above.
